

Summary of carboNZero certification

Apex General Limited meets the requirements of carboNZero^{Cert™} certification having measured its greenhouse gas emissions in accordance with the requirements of ISO 14064-1:2006, committed to managing and reducing its emissions and neutralised its remaining unavoidable emissions through the cancellation of an appropriate number of verified carbon credits in respect of the operational activities of its organisation.



Introduction¹ – Apex General Limited is a New Zealand privately owned insurance brokerage. Apex General entered the carboNZero programme to understand and measure waste from our business so we can improve and eliminate waste & costs associated with running our business. This certification gives us a measure to improve over future years and we are excited by the opportunities and challenges it presents us.

Boundary – The boundary for the preparation of the organisation's greenhouse gas (GHG) inventory is for one site. All business activities have been included.

Consolidation approach – The operational control consolidation approach has been used to account for operational emissions with reference to the methodology described in the GHG Protocol and ISO 14064-1:2006 standards.

Base year – 01/04/2011 to 31/03/2012

Measurement period – 01/04/2014 to 31/03/2015

Emissions source inclusions – The operational GHG emissions for the organisation by emissions source are shown in the figure below.

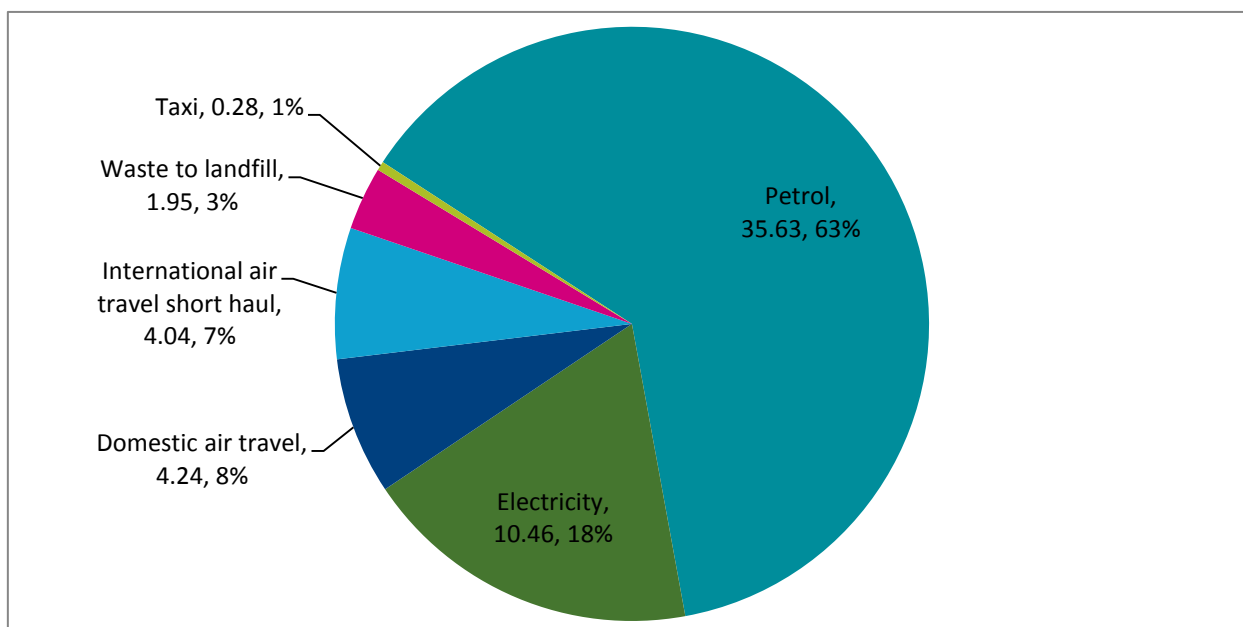


Figure 1: GHG emissions by emissions source.

Emissions source exclusions – The following emissions sources were excluded from the inventory for this measurement period:

- Couriers/freight: Audit process demonstrated \$ expenditure is *de minimis*

Emissions reduction commitments – A GHG emissions management plan and reduction targets have been developed.

- Manage and reduce fuel consumption by 5%
- Manage and reduce electricity use by 5%
- Reduce rubbish by 5%

Emissions reduction report against last year's plan – This is the fourth year of reporting under carboNZero programme. An absolute reduction in Scope 1 and 2 emissions of 8.79 tCO₂e has been achieved against base year. A reduction in emissions intensity (for Scope 1, 2 and mandatory Scope 3 emissions) of 4.95 tCO₂e/\$M has been achieved; based upon a 5 year rolling average.

Offset – 57 credits (comprised of 16 PFSI AAUs Pigeon Bush NZ Forest credits and 41 PFSI Hinewai NZ Forest credits) have been cancelled on the carboNZero register and will be cancelled (or equivalent) on the relevant external registry within one month of certification.
