

# Summary of carboNZero certification

**Introduction<sup>1</sup>** – IncaFé produces award-winning premium Fairtrade Organic coffee, directly sourced from growers, roasted to perfection in NZ's first organic and carboNZero certified roastery. The rapid change in climate is one of the scariest things to be confronted with and for example the impact on coffee growing is very noticeable. 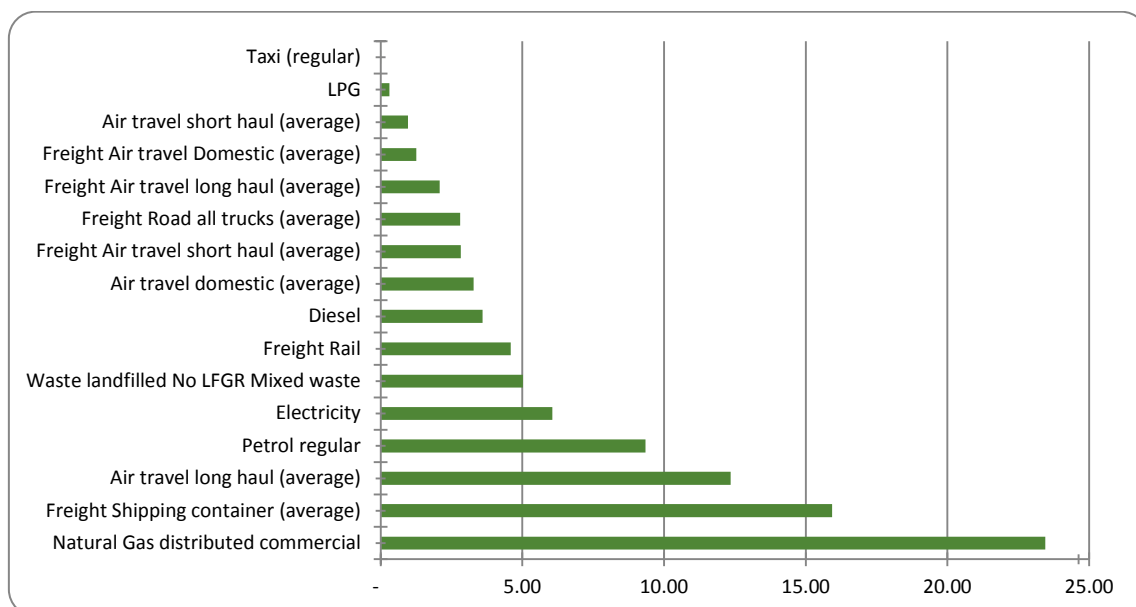
**Boundary** – The boundary for the preparation of the organisation's greenhouse gas (GHG) inventory is for one site. All business activities have been included.

**Consolidation approach** – The operational control consolidation approach has been used to account for operational emissions with reference to the methodology described in the GHG Protocol and ISO 14064-1:2006 standards.

**Base year** – 1/09/2007 to 31/08/2008

**Measurement period** – 1/09/2016 to 31/03/2017<sup>2</sup>

**Emissions source inclusions** – The operational GHG emissions for the organisation by emissions source are shown in Figure 1 below.
